The type of personal information we collect

We currently collect and process the following information:

How we get the personal information and why we have it

We use the information that you have given us in order to

- where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests;
- where we need to comply with a legal or regulatory obligation; and
- to keep a record of your relationship with us

Your personal data is stored with us only and will not be shared with any third parties unless such is required to fulfil our contract terms with you.

We will never share or sell your personal data with any third party that intends to use the same for direct marketing purposes.

We will never transfer or store any of your personal data outside of the United Kingdom.

How we store your personal information

Your information is securely stored.

Your data protection rights

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
